The Applicant confirmed during Issue Specific Hearing 17 on 28 May 2021 that following receipt and review of the further infiltration test results, the Applicant will submit an updated Outline Operational Drainage Management Plan and an updated Outline Landscape and Ecological Management Strategy. It is anticipated that these documents will be submitted on 11 June 2021 and the Applicant requests that the Examining Authority accept these as additional submissions into the Examination.

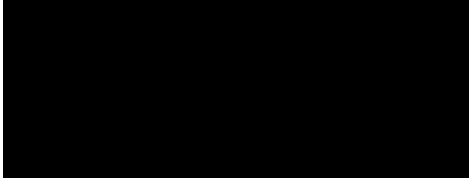
