Dear Mrs. Fulford.

Thank you for your response to our request for survey access over land you own. I have set out the answers to your questions below.

I am pleased to confirm that the survey request relates to a proposed cable which would link the electrical infrastructure between Kent and Suffolk. At this stage the specific route station is unknown and identifying a cable route and converter station location forms part of the reasoning behind the surveys which will be taking place over the next couple of ye At this stage the surveys planned are Non- Intrusive, predominantly ecological surveys of wintering birds

In relation to your question on what rights of access do National Grid have to access your land, they have rights of access granted to them by statute. These can be found in Section of the Housing and Planning Act 2016 and Paragraph 10 of the Schedule 4 of the Electricity Act 1989. These pieces of statute allow National Grid to use compulsory purchase po Statutory Undertaker, to enter land for the purposes of surveys. However, please be assured that National Grid do not want to rely upon Statute for access, it is far more equitable voluntary basis. If you are not comfortable in allowing National Grid on at this stage, please let me know and I will inform National Grid of your decision.

Finally, we are aware the Nautilus project are conducting a number of similar surveys in the local area at this time. There have been many discussions within National Grid to try a programmes for these two cables, however it has been decided that at this stage the surveys need to be conducted separately. If that was to change, I will ensure you are informed
