2. INTRODUCTION AND SCOPE

2.1 OVERVIEW

ScottishPower Renewables and Vattenfall have been working collaboratively on the delivery of the lesser black-backed gull (LBBG) compensation requirements for East Anglia ONE North and TWO (hereafter referred to as the 'East Anglia Projects') and Norfolk Boreas and Norfolk Vanguard (hereafter referred to as the 'Norfolk Projects'). Further details of the collaborative approach are provided in Section 1.2 and 1.3 of the LBBG Implementation and Monitoring Plan (LBBIMP).

Under the Norfolk Projects and East Anglia Projects' consents, there are requirements to set up LBBG Compensation Steering Groups (LBBCSG) to discuss and agree the delivery of LBBG compensation. The Norfolk Projects, due to their requirement to deliver a greater level of compensation, set up the LBBGSCG and took a secretarial role. Representatives of the East Anglia Projects were in attendance for the third and fourth LBBCSG Meetings (12th August 2022 and 5th October 2022, respectively).

This predator control LBBIMP has been prepared pursuant to Paragraph 3 of Schedule 18, Part 2 of the East Anglia ONE North DCO and Paragraph 3 of Schedule 18, Part 2 of the East Anglia TWO DCO; both hereafter referred to as the "compensation schedules".

During the third Norfolk Project's LBBCSG it was agreed that any discussions and subsequent agreements on compensation that were made at the Norfolk Projects-led meetings are applicable for the East Anglia Projects and therefore have been carried through into the East Anglia ONE North and TWO LBBIMP.

On the basis of this agreement, ScottishPower Renewables has prepared this Agreement Log utilising agreements made between the Norfolk Projects and members of the LBBCSG. The Agreement Log has been updated to reflect specific comments and positions for the East Anglia Projects. ScottishPower Renewables has sought to confirm agreement on these matters with the LBBCSG.

A consultation report has been produced by the Norfolk Projects¹. This reports on consultation which has occurred to date in order to develop the LBBG compensation for the Norfolk Projects and the East Anglia Projects, collectively.

2.2 THE LBBG COMPENSATION STEERING GROUP MEMBERS

The members of the LBBCSG include;

- East Anglia ONE North and TWO;
- The Norfolk Projects;
- East Suffolk Council (ESC),
- Marine Management Organisation (MMO),
- Natural England (NE), and
- Royal Society for the Protection of Birds (RSPB).

The independent chairperson appointed to oversee the LBBCSG was Jim McKie.

The Steering Group aims to:

- Deliver the LBBG compensation in an effective and timely manner,
- Establish an appropriate monitoring plan to ensure continued success of the LBBG compensation, and
- Develop appropriate adaptive management measures to ensure LBBG compensation is effective.

The agreement log has been structured to reflect the topics of discussion between the members of the LBBCSG. The agreement log outlines all topic specific matters agreed, not agreed and any actions to resolve the areas of disagreement. Matters that are not agreed will be the subject of ongoing discussion wherever possible to resolve or refine the extent of disagreement between the parties.
