As required by your letter of 21<sup>st</sup> February, please accept this email as confirmation that my client Graeme Bloomfield wishes to attend the meeting on 24<sup>th</sup> March and reserve the right to speak. Mr Bloomfield will be acting for himself and his wife, but also on behalf of his company Fielden Limited. We would like to at this point reserve the right to substitute Mr Bloomfield with Counsel, and would of course notify you as soon as possible if this was the case.

Mr Bloomfield and Fielden Limited are also an Interested Party in East Anglia Two.

Our clients would ask that the Panel consider as an issue for subsequent consideration the basis and manner in which Scottish Power Renewables (SPR) are seeking to acquire land and rights which affect their property; and that SPR has failed to provide sufficient information and certainty as to the likely duration of works and the length of “temporary” occupation and the failure to address the severe and injurious impact on our client’s property to the extent that there has been a failure of consultation of the required front-loading of the DCO process.

Our clients would also like to have addressed issues relating to the consideration of issues for compulsory purchase of land and rights and the absence of suitable provision in the DCOs therefore. We will, of course, be making substantive representations as required for the Compulsory Acquisition Hearing but for the hearing on 24th March this would be as regards the identification of the issues of concern and how they can be addressed.
