## Planning Act 2008, Scottish Power Renewables Limited, Proposed East Anglia One North Offshore Wind Farm

### Response to Examining Authority's Rule 6 Letter

On 16 December 2019, the Marine Management Organisation (the "MMO") received notice under section 55 of the Planning Act 2008 (the "PA 2008") that the Planning Inspectorate ("PINS") had accepted an application made by Scottish Power Renewables Limited (the "Applicant") for determination of a development consent order for the construction, maintenance and operation of the proposed East Anglia Two Offshore Wind Farm (the "DCO Application").

The Applicant seeks authorisation for the construction, operation and maintenance of DCO Application, comprising of up to 75 wind turbine generators together with associated onshore and offshore infrastructure and all associated development ("the "Project").

The MMO received a Rule 6 letter on 16 July 2020, which superseded the Rule 6 letter of 21 February 2020, following the postponement of the Examination Timetable on 17 March 2020.
