Application by East Anglia TWO Limited for an Order Granting Development Consent for the East Anglia TWO Offshore Wind Farm

Changes to the Examination Timetable, notification of procedural decisions, hearings and accompanied site inspections

Following our acceptance of the Applicant's recent request for changes to the Proposed Development, and the necessary consultation arising from the request, it is necessary to amend the Examination Timetable. Changes are also proposed to respond to the need for additional hearing time to ensure that all outstanding requests to be heard at Open Floor Hearings (OFHs) are met and issues heard at Issue Specific Hearings (ISHs).

This letter provides you with the updated Examination Timetable, which replaces the one that was included in our Rule 8 letter of 12 October 2020¹. All documentation associated with this project can be found on the project page of the Planning Inspectorate's National Infrastructure website:

Other changes have been made to the Examination Timetable and these are summarised below:

Notification of Hearings and Accompanied Site Inspection

The ExA has decided to hold the further ISHs and OFHs in the week commencing 18th and 25th January 2021, namely:

- **Issue Specific Hearing 3 (ISH3)** into Biodiversity and Habitats Regulations Assessment on 19 January 2021;
- **Issue Specific Hearing 4 (ISH4)** into Onshore Environment, construction, transport and operation effects on 19 and 20 January 2021;
- **Issue Specific Hearing 5 (ISH5)** into Social, economic, land and sea use effects on 21 January 2021;
- **Issue Specific Hearing 6 (ISH6)** on the draft Development Consent Order 29 January 2021;
- **Open Floor Hearing 6 (OFH6)** on 22 January 2021; and
- **Open Floor Hearing 7 (OFH7)** on 28 January 2021.

Log of Procedural Decisions made by the Examining Authorities

The ExAs have made the following groups of procedural decisions¹:

- **Procedural decisions made in the pre-examination period** before the Preliminary Meeting, initially to support Examination including physical hearing events before the onset of the Covid-19 pandemic, and then to ensure continued preparation for Examination using Covid-safe methods. There are 19 of these decisions, numbered in date order from 1 to 19, of which 5 have been superseded and cancelled and 14 remain in effect having been confirmed following the Preliminary Meeting.
- **Procedural decisions made following the Preliminary Meeting.** There are 3 of these, numbered in sequence from 20 to 22. These decisions are set out in full in the **Rule 8 Letters** of 12 October 2020. Noting that some elements of these decisions were contested in written and oral submissions to the Preliminary Meeting, a statement of reasons was also provided and can be accessed by a hyperlink from those letters.
- **Procedural decisions made during the Examinations.** There are currently four of these, numbered 23 to 26, relating to:
 - **PD 23:** requests by the Applicants for changes to the applications including the inclusion of additional land;
 - **PD24:** a decision by the ExA not to issue a second round of written questions (ExQ2);
 - **PD 25:** a decision by the ExA to accept non-material revisions to details of the onshore substations (updated details of finished ground levels and height of structures); and
 - **PD 26:** a decision by the ExA to amend the timetables to respond to requests by the Applicants for changes to the applications and to provide additional time for Open Floor and Issue Specific Hearings (set out in this Letter and Annexes).

People who have land or rights affected by Compulsory Acquisition or Temporary Possession are Affected Persons: you have a right to be heard at a Compulsory Acquisition Hearing (CAH) and that will be the best forum to raise those issues.

OFHs aim to identify planning issues that are important and relevant. Once an issue has been identified it does not need to be repeated. It is sufficient to say that you agree with something a previous speaker has raised.

Once you have spoken at one OFH you do not have a right to speak again at another. It is important that you use your allotted time well to communicate your messages to the ExAs.

Any new evidence presented orally at these hearings (including written submissions of oral cases) should be included in post-hearing submissions and submitted at Deadline 5.

Participation is subject to the ExA's power to control the hearing.
