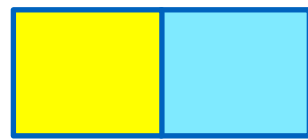

# 1 Introduction

## 1.1 Background

1. This document is applicable to both the East Anglia ONE North and East Anglia TWO applications, and therefore is endorsed with the yellow and blue icon used to identify materially identical documentation in accordance with the Examining Authority's (ExA) procedural decisions on document management of 23rd December 2019. Whilst for completeness of the record this document has been submitted to both Examinations, if it is read for one project submission there is no need to read it again for the other project.
2. This Statement of Common Ground (SoCG) has been prepared between East Anglia TWO Limited, East Anglia ONE North Limited (hereafter the Applicants) and the Marine Management Organisation (MMO) in relation to the East Anglia TWO project and the East Anglia ONE North project (the Projects). It identifies areas of the Projects' Development Consent Order (DCO) applications (the Applications) where matters are agreed or not agreed between the parties.
3. The Applicants have had regard to the guidance for the examination of applications for development consent (Department for Communities and Local Government, 2015) when compiling this SoCG.
4. This SoCG has been structured to reflect topics of interest to the MMO on the Applications. Topic specific matters agreed, not agreed and actions to resolve between the Applicants and the MMO are included within this SoCG.
5. The tables presented below are the basis for a SoCG with the Applicants and the MMO in respect of the following topic(s):
  - Marine Geology, Oceanography and Physical Processes;
  - Marine Water and Sediment Quality;
  - Benthic Ecology;
  - Fish and Shellfish Ecology;
  - Commercial Fisheries;
  - Marine Mammals; and
  - Draft, Outline and In-Principle Plan Documents.
6. Throughout the SoCG the phrase "Agreed" identifies any point of agreement between the Applicants and the MMO.
7. The phrase "Not Agreed" identifies any point that is not yet agreed between the Applicants and the MMO. Points that are not yet agreed will be the subject of



ongoing discussion between the Applicants and the MMO to reach agreement on the point wherever possible or refine the extent of disagreement between parties. The notes column of the SoCG tables provides commentary on these matters.

8. The tables in **section 2** are based upon discussions and information exchanged between the Applicants and the MMO during the pre-application and examination phases of the application.

## 1.2 The Development

9. The key offshore components of each project will comprise:

- Offshore wind turbines and their associated foundations;
- Offshore platforms - up to four offshore electrical platforms and their associated foundations supporting some of the windfarm's electrical equipment, and up to one construction, operation and maintenance platform and associated foundations that may cater for personnel and activities required during the construction phase and operation and maintenance of the windfarm;
- Sub-sea cables between the wind turbines and between wind turbines and offshore electrical platforms (inter-array), between separate offshore platforms (platform link cables) and between offshore electrical platforms and the landfall (export cables);
- Scour protection around foundations and on inter-array, platform link and export sub-sea cables as required; and
- Potential for one meteorological mast (met mast) and its associated foundations for monitoring wind speeds during the operational phase of the windfarm.

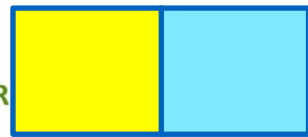
10. The key onshore components of each project will comprise:

- The landfall site with up to two transition bays to connect the onshore and offshore cables;
- Up to six onshore cables, up to two fibre optic cables and up to two distributed temperature sensing cables installed underground (some or all of which may be installed in ducts) and associated jointing bays installed underground;
- Onshore substation; and
- Electrical cable connection between onshore substation and National Grid substation.

11. National Grid infrastructure will also be required to connect each project to the national electricity grid. Key components of the National Grid infrastructure which is common to both projects will comprise:

- National Grid substation;





- Cable sealing end compounds and a cable sealing end (with circuit breaker) compound; and
- Realignment of the existing overhead lines; including the reconstruction or replacement of up to three existing overhead pylons in proximity to the National Grid substation and the addition of up to one new pylon in close proximity to existing overhead pylons.

## 2 Statement of Common Ground

13. The areas of agreement and disagreement between the Applicants and the MMO are set out below.
14. Additionally, the Applicants and the MMO note the general engagement that has been undertaken since submission of the Applications and how that correlates with this SoCG and the examination process for the Applications.
15. The MMO submitted its relevant representation on 27<sup>th</sup> January 2020 (RR-052). The Applicants submitted the Applicants' Comments on the Relevant Representations (AS-036) in response to Procedural Decision 11 (11<sup>th</sup> June 2020);
16. Two multi-party workshops were held with the MMO and other stakeholders in late July and early August 2020 to discuss offshore ornithology, and marine mammals and other offshore matters.
17. Through the SoCG engagement process, the MMO provided comments in response to the Applicants' Comments on the Relevant Representations (AS-036) on 8<sup>th</sup> September 2020. Following this, the Applicants provided a further response to the MMO on the 12<sup>th</sup> October 2020.
18. This engagement since submission of the Applicants' Comments on the Relevant Representations (AS-036) has allowed both parties to agree a large number of the matters raised in the MMO relevant representation (RR-052), which is reflected in this SoCG. Furthermore, the Applicants and the MMO agreed that due to time constraints some of the outstanding matters requiring engagement between the MMO and its advisor Cefas, would not be addressed within the draft SoCG, but rather that the engagement will be reflected in the MMO's written representation submission into the examination at Deadline 1 and in an updated SoCG for submission at Deadline 3.

### 2.1 Marine Geology, Oceanography and Physical Processes

19. Each project has the potential to impact upon marine geology and physical processes. **Chapter 7 Marine Geology, Oceanography and Physical Processes** of the Environmental Statement (ES) (APP-055) provides an assessment of the significance of these impacts.
20. **Table 2.1** provides an overview of meetings and correspondence undertaken with the MMO regarding marine geology, oceanography and physical processes.
21. **Table 2.2** provides areas of agreement and disagreement with the MMO regarding marine geology, oceanography and physical processes.
