Access Required Site Inspections and Unaccompanied Site Inspections held in place of Accompanied Site Inspections 1 and 2 (ASI1 & ASI2)

Notice was provided for ASI1 and ASI2 in the Examining Authorities' (ExAs') Rule 8(3) Letter of 8 December 2020¹ at Annex E. Since the service of notice, infection rates in many parts of the country have climbed significantly and new measures to prevent the spread of Coronavirus in England have been put in place. Inspections themselves are essential work for the purposes of relevant public health regulations and guidance, but the regulations and guidance require the ExAs to ensure that only those with an essential need to attend inspections now attend and that inspections are conducted in a socially distanced manner to minimise any risk of infection.

Planning Inspectorate Coronavirus advice on gov.uk and on virtual events in NSIP Examinations highlight the need for ExAs to move swiftly to ensure that site inspections are conducted in accordance with public health regulations and guidance. The published notices for ASI1 and ASI2 highlighted that changes to itineraries may be made up to the day of the inspection to respond to changing public health circumstances. On this basis, the ExAs have made changes to the arrangements for these site inspections to limit attendance to those whose presence is essential to enable inspections to proceed. In summary terms, such people are the landowner, occupier, their agent or delegate able to permit access, open any locked entrances and direct the ExA to relevant parts of the site. Where a site inspection relates to a specific feature (for example, archaeological significance), it can be essential for the person on site to be a technical expert, able to identify relevant locations and features. Public attendance by groups who might wish to attend but whose attendance is not essential is no longer supported. In those circumstances it is important that the only people who attend inspection locations are those who have been requested to attend by the ExAs. The Case Manager will contact all those whose attendance has been requested. These inspections are described as access required site inspections (ARSIs).

In certain circumstances, where inspections are proposed to be carried out in the public domain and information already available to the ExAs includes routes or descriptions of features to be seen, the ExAs have decided that no public attendance is necessary, and these inspections will take place as unaccompanied site inspections (USIs).

If you are a person who had originally wished to attend an inspection but whose presence is now not deemed to be essential, in recognition of this change the ExAs have agreed to publish a written inspection note shortly after the inspections are concluded, confirming the inspections that were completed. You can make your own summary observations in writing on the condition and specific features of the inspected sites. Any notes that you submit can be supported by maps, plans, drawings, photographs and videos. They should be submitted to the project mailboxes by Deadline 5 (3 February 2021).

For those still attending, the ExAs have provided a separate document on site protocols and measures to control Coronavirus related risks that we ask you to read, sign and return before the inspections begin. The site inspection will involve some walking and we therefore request that attendees wear appropriate clothing for the weather, and sturdy footwear. We would like to remind all participants that the

site inspection is not an opportunity to make any oral representations on the application, but simply an opportunity to identify physical features that are relevant to the examination. The itinerary for both days is set out below. An illustrative plan is included at Annex A.
