**Application by East Anglia TWO Limited for an Order Granting Development**  
**Consent for the East Anglia TWO Offshore Wind Farm**  
**Notification of Issue Specific and Compulsory Acquisition Hearings**

The Examining Authority (ExA) has decided to hold further Issue Specific Hearings (ISH) and further Compulsory Acquisition Hearings (CAH2) in the week commencing 15 February 2021, namely:

- **Compulsory Acquisition Hearing 2 (CAH2)** on 16 February 2021;
- **Issue Specific Hearing 7 (ISH7)** into Biodiversity and HRA on 17 February 2021;
- **Issue Specific Hearing 8 (ISH8)** into Seascapes on 18 February 2021; and
- **Issue Specific Hearing 9 (ISH9)** on the draft Development Consent Order on 19 February 2021.

Important information about all of these hearings can be found in Annex A. We are proposing that these ISH and CAH2 will all be held virtually and in parallel with the ISH and CAH2 for the East Anglia TWO Examination.

The Examination timetable has been amended, specifically at **items 30 to 33**, whilst items 34-40 of the timetable remains unamended, refer to **Annex B**. The reasons for the change is to ensure that each individual hearing is now held on its own single day. Whilst hearings will not extend for any longer than required, this does make a contingency provision for longer hearings for both biodiversity and seascapes matters if required. The remit of ISH8 has also been clarified to focus it on seascapes (as yet not examined in oral hearings), noting that landscapes have already been the subject of hearings - ISH2.



I refer further to guidance on how virtual events will be held and how you can get involved within the [Frequently Asked Question 3.0](#).

Please note that for ISHs and CAHs the ExA will aim to publish a detailed draft agenda on the project website at least five working days in advance of the hearing date. However, the actual agenda on the day of each hearing may be subject to change at the discretion of the ExA.

CAH agendas will be published that establish a running order to facilitate the hearing process on the day and to structure the time available for participants to speak. They will not specify the subject matters on which participants may speak, although it should be noted that the purpose of these hearings is to enable those objecting to compulsory acquisition and or temporary possession proposals to be heard. The CAHs will be managed with that purpose in mind.

The deadline to notify the case team of attendance is Deadline 5 (3 February 2021).

### Notification of Hearings under Rule 13 of the Examination Procedure Rules 2010 - Section 92 of the Planning Act 2008

Notification of the date, time and place for the second Compulsory Acquisition Hearings (CAH2) under Rule 13 of the Infrastructure Planning (Examination Procedure) Rules 2010.

Compulsory Acquisition Hearings provide an opportunity for the ExAs to examine the Applicants' case for compulsory acquisition (CA) and temporary possession (TP) and for the Applicants and Affected Persons (APs) to make oral representations about these matters. CAH2 will consist of hearing initially from individual objections to CA and/ or TP relating to individual parcels of land and/ or interests in land, followed by hearing from the applicants both on matters raised by individual objections and other matters outstanding from CAH1.

CAH2 is to be held in parallel and for the same purposes for both the East Anglia ONE North and the East Anglia TWO Examinations. Further guidance on the relationship between the East Anglia ONE North Examination and the East Anglia TWO Examination can be found in the **FAQs**.
