Examining Authorities' Note of Unaccompanied Inspections of Sites Undertaken 6 & 7 January 2021 (USI6)

Background

The Examining Authorities (ExAs) undertook their sixth unaccompanied site inspections (USI6) on 6 and 7 January 2021 to support examinations of applications for development consent for the proposed East Anglia ONE North and East Anglia TWO Offshore Wind Farms (the applications).

The main purpose of the inspections was to view landscapes and seascapes at and from the Orfordness peninsula, a substantial shingle spit coastline that is inaccessible by road. Orfordness forms part of the Suffolk Coast and Heaths Area of Outstanding Natural Beauty and is also a National Nature Reserve. Earlier inspections did not gain access to it, due to the closure of public access during the Covid pandemic, but having viewed the coast north from Felixstowe to Caister on Sea, this approximately 16 km peninsula shoreline remained as the most substantial element of the coast that had not been inspected. Arrangements for access were made via the National Trust and enabled inspections at Orfordness to be undertaken by Rynd Smith and Jon Hockley.

The ExAs also used this opportunity to complete its programme of traffic and transport related inspections, including at locations requested by IPs. Guy Rigby undertook these inspections.

Further inspections were also undertaken by Rynd Smith, Jon Hockley and Guy Rigby to observe existing offshore wind farms at night from Aldeburgh beach. Potential historic heritage effects in Lowestoft and landscape impacts at Friston raised in a submitted Local Impact Report [REP1-132] and considered in evidence in Issue Specific Hearing 2 (ISH2) were undertaken by Jon Hockley and Mr Hockley and Rynd Smith respectively.

The inspections are recorded in this note, the purpose of which is to inform the Applicants, Interested Parties (IPs) and other persons of actions taken by the ExAs. A single note has been produced. It is endorsed with the yellow and blue icon used to identify materially identical documentation in accordance with the ExAs' Procedural Decisions 3 on document management of 23 December 2019¹. Whilst this note has been published to the Examination Libraries for both applications, if it is

read in one library, there is no need to read it again in the second library. Previous site inspection notes can also be found in both libraries² on the same basis.

Careful consideration has now been given to all site inspection nominations by the Applicants and IPs. Accompanied Site Inspections (ASIs) programmed be held on 26 and 27 January 2021 were amended into a combination of Access Required (AR) and unaccompanied site inspections (USI7) held on 25, 26 and 27 January 2021. Itineraries for these can be found in both libraries³. Additional USIs may be held if new issues requiring to be inspected arise, and notes of these would also be published, but in principle the requests for site inspections made by IPs have now been addressed. It should be noted that the ExAs can decide not to visit nominated locations where they consider that it is not necessary to see them or the features requested to be observed in order to make recommendations to the Secretary of State.

Particulars of the Inspections

The inspections were undertaken by members of the ExAs consisting of Rynd Smith (Lead), Jon Hockley and Guy Rigby. The purposes of the inspections were to:

- observe existing offshore wind farm installations from the coast at night;
- extend the ExAs' review of the Applicants' seascape impact assessments into land at Orfordness that was not accessible during previous inspections;
- complete traffic and transport inspections;
- carry out historic heritage inspections; and
- consider landscape impacts.

The inspections were carried out over two days.

Orfordness Seascapes Route – the inspections reviewed locations referred to in evidence of the applicant and Natural England. Sites were inspected at or as close as possible to the locations from which the Applicants' seascape visualisations were obtained. They were undertaken on 7 January 2021 by boat from Orford Quay to Orfordness Quay and then on foot once on the Orfordness peninsula, commencing at 10:00am, concluding at 3:00pm. Weather conditions were dry and initially overcast but brightening later and with good long-range and sea horizon visibility throughout.

Traffic and Transport Inspections – the inspections viewed locations proposed in the applications for highways works or subject to traffic and transport impacts, including locations proposed by the applicants and IPs. The inspections were undertaken on the afternoon of 6 January 2021 by car between 2:30pm and 4:00pm, and also on 7 January 2021 by car and then on foot, commencing at 09:00am at Aldeburgh and concluding at approximately 3:30pm at Saxmundham. Weather conditions were dry and cloudy with good visibility. There were some locations where it was either not possible or not safe to stop for an inspection on

foot, and these are noted below, but it was nevertheless possible to appreciate views of the proposed highways works locations and of other highways locations of interest to the ExAs.

Aldeburgh Beach Night Inspection – the inspection was undertaken on foot on Aldeburgh beach after nightfall, between 7:00pm and 7:30pm on 6 January 2021. The purpose of the inspection was to observe the visibility, effect and extent of sea horizon affected by lighting on constructed offshore wind farms at night, enabling wind turbine generator (WTG) lighting to be seen. Weather conditions were dry with a dark sky providing good long-range and sea horizon visibility.

Historic Heritage – the inspections viewed locations raised by Suffolk County Council and East Suffolk Council in their joint local impact report [REP1-132] as relevant to the assessment of the impact of the proposed offshore infrastructure on heritage assets, including the South Lowestoft Conservation Area and listed buildings within this area, including group listings of large terraces at Wellington Esplanade, Victoria Terrace, and Kirkley Cliff Terrace. Inspections were undertaken on 6 January 2021 on foot commencing at 2:30pm and concluding at 3:45pm. Weather conditions were dry and reasonably clear.

Landscape Inspections – the inspections viewed agricultural buildings located at Red House Farm as referred to in evidence both in writing and verbally at ISH2. These were viewed from a nearby footpath and were undertaken on foot on 7 January 2021 commencing at 3:30pm and concluding at 4:00pm. Weather conditions were dry and clear.

The individual locations inspected over both days and the purposes of those inspections are recorded below with route maps provided at **Annex A**. Route and location numbers as shown on the maps are set out below.

Reference to Environmental Statement Viewpoints (ES VP) is taken to be to Figures 28.5 and 29.4 for seascape and onshore receptors (Examination Library references [APP-319] and [APP-394] respectively); these references are common to both applications.





Key Plans (North to South)





Orfordness Seascapes Route








