National Grid's submissions at CAH2

SASES noted that National Grid attended and made submissions at CAH2. In particular there were submissions on:

1. whether the National Grid infrastructure (substation, cable sealing ends and additional pylons/pylon realignment) would be reduced in size if only one of EA1N or EA2 was constructed; and
2. the expansion/use of such infrastructure for other projects which were planned to/ likely to connect to the grid at Friston.
