Ground investigation works are planned to take place across the East Anglia TWO and ONE North onshore development area between March and August 2021.

These advance surveys are necessary to feed into the cable route and substation design and to gain a better understanding of the environmental mitigations required should the DCO application be successful, as well as to aid with the timely delivery of renewable energy to the area.

This process of early investigations is routine to support the design and suitable mitigation for the development should consent be granted. All works have been carefully planned to work closely with the ecological team and will only take place with their approval.

The investigations will take place at various locations along the proposed 9km cable corridor and at the substations site. No investigations will take place within the Leiston-Aldeburgh Site of Special Scientific Interest (SSSI) or Sandlings Special Protection Area (SPA) during the bird nesting season.

SPR representatives are currently working across the site to mark out the proposed site boundary for the works to commence.

The work will include small teams of people investigating the ground at various locations across the proposed development area using different methods including, soil and groundwater sampling, heritage feature and topographic surveys. This is to assess the baseline condition of the ground to inform future possible design and construction phases.

Scottish Power Renewables recognises the critical importance of the local environment. In planning the ground investigation, the locations around the site have been chosen to minimise disturbance to the people, places and landscape within which the investigation will take place. No works are planned on Public Rights of Way and no diversions to them are planned.


