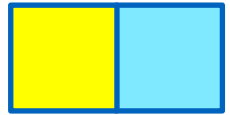

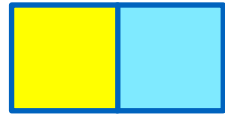

1 Introduction

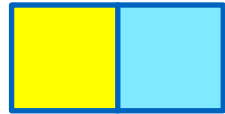
