Please see below regarding Questions under EPR Rule 17 (R17QC) to the Nuclear Decommissioning Authority.

Question

The role of Magnox Ltd

Are there any reasons why the interests of Magnox Ltd in the applications and the decommissioning process for Sizewell A nuclear power station cannot be addressed by an answer to R17QD.2 below from the NDA?

- If so, the NDA is requested to refer the following question to Magnox Ltd and annex any contribution from that body to its response.

NDA Response

Question

Matters bearing on the decommissioning process for Sizewell A Nuclear Power Station

The NDA is asked to consider the submitted applications for both proposed developments and relevant examination documents¹.

- Are there any remaining matters arising that were not considered in the Statements of Common Ground (SoCGs) concluded between the NDA, Magnox Ltd and the Applicants on 25 March 2021 but which are relevant to the decommissioning process for Sizewell A nuclear power station that should be considered by the Secretary of State before decisions are made on the applications?
- If so, please identify those matters, making appropriate reference to applicable National Policy Statement policy.
- If not, please respond to this question, placing on record your position that there are no such remaining matters.

NDA Response

There are no remaining matters that were not covered by the SoCG (REP8-130) concluded between NDA, Magnox Ltd. and the Applicants on 25 March 2021 that are relevant to the decommissioning process for Sizewell A that should be considered by the Secretary of State.

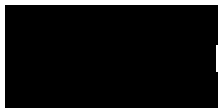
