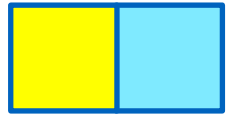

1 Introduction

1.1 Project Background

1. East Anglia TWO Limited and East Anglia ONE North Limited ('the Applicants') are seeking Development Consent Orders (DCO) in relation to the East Anglia TWO project and the East Anglia ONE North project ('the Projects'), two offshore wind farms in the southern North Sea.
2. This document is applicable to both the East Anglia ONE North and East Anglia TWO applications, and therefore is endorsed with the yellow and blue icon used to identify materially identical documentation in accordance with the Examining Authority's procedural decisions on document management of 23rd December 2019. Whilst for completeness of the record this document has been submitted to both Examinations, if it is read for one project submission there is no need to read it again for the other project.
3. It should be noted that some Statements of Common Ground (SoCG) are relevant to the East Anglia TWO Project or the East Anglia ONE North project only, however these have been included within this joint document for ease of reference. The SoCG which are relevant to the East Anglia TWO Project only are with:
 - East Anglia ONE Limited
4. The SoCG which are relevant to the East Anglia ONE North Project only are with:
 - Interconnector (UK) Limited

1.2 Purpose of the Statement of Commonality

5. This document provides the Examining Authority with an overview of the position of each SoCG between the Applicants and the interested parties in relation to the Projects at Deadline 12 (28th June 2021).
6. Throughout the Environmental Impact Assessment (EIA), the Applicants have coordinated an Evidence Plan Process (EPP) which provided a framework for consultation with the relevant stakeholders. Each SoCG reflects discussions which took place throughout the EPP, pre-application consultation as well as the post-application consultation.



1.3 Structure

7. This report is structured as follows:
