1 Introduction

- 1. This document has been prepared by East Anglia ONE North Limited and East Anglia TWO Limited (the Applicants) in relation to the East Anglia ONE North project and the East Anglia TWO project (the Projects) and provides an audit of the approval and consultation processes for outline and in-principle plans and strategies secured by Requirements of the *draft Development Consent Order* (DCO) (document reference 3.1). This document has been prepared in response to the Examining Authority's (ExA) *Commentary on the Projects' draft DCO* (PD-048) on 20th May 2021.
- 2. This document, is applicable to both the East Anglia ONE North and East Anglia TWO DCO applications, and therefore is endorsed with the yellow and blue icon used to identify materially identical documentation in accordance with the Examining Authority's procedural decisions on document management of 23rd December 2019 (PD-004). Whilst this document has been submitted to both Examinations, if it is read for one project submission there is no need to read it for the other project submission.
- 3. In response to Hearing Action Point 7 arising from the Issue Specific Hearing (ISH) held virtually on Friday 28th May 2021 and the ExA's commentary on the Projects' draft DCO, a final audit of all documents referred to in Schedule 17 of the *draft DCO* was undertaken at Deadline 12 and the Applicants confirmed in the *Certified Documents (Schedule 17) Audit* (REP12-064) that the names, version numbers and dates of all documents specified within Schedule 17 of the *draft DCO* submitted at Deadline 12 were correct.
- 4. At Deadline 13, the Applicants have submitted updated versions of the following certified documents listed in Part 2 of Schedule 17 of the draft DCO:
 - a. Outline Code of Construction Practice;
 - b. Outline Landscape and Ecological Management Strategy; and
 - c. Outline Operational Drainage Management Plan.
- 5. In addition, the Applicants have submitted a **Deadline 13 Offshore Ornithology Cumulative and In Combination Collision Risk and Displacement Update**.
- 6. As a result of the documents submitted at Deadline 13, there are a few minor updates that will need to be reflected in Schedule 17 of the DCO should consent be granted.
