Norfolk Vanguard Offshore Wind Farm - Survey Access Request

Vattenfall, a Swedish state owned energy company, is currently exploring the potential to build an offshore wind farm located in the North Sea. This could produce up to 1.8GW of electrical energy, enough to power up to 1.3m homes per annum¹.

We sent you a Norfolk Vanguard Newsletter in October, and write to you again now as we believe land owned or occupied by you, in title no NK224913, NK355739 and within the area shown on the enclosed plan may potentially be affected.

The plan shows the onshore ecological survey area to further investigate options where we propose to locate landfall (of cables from the wind farm), cable relay station, underground cables and substation to connect into the National Grid at the existing 400kV National Grid substation near Necton. Following a series of open Drop-in exhibitions in October, 2016 – attended by more than 780 local people, and consultation with the Planning Inspectorate and Statutory Consultees, we have been able to refine our search area, as per the plan.

We would now like to carry out ecological surveys to help us develop a more detailed onshore infrastructure plan. These surveys are significant in providing information relating to local biodiversity over a wide preliminary investigation area. Studies of this nature will help us become more aware of ecological constraints at an early stage, so that the development can be designed to limit or avoid harm to protected species such as newts, badgers, reptiles and birds. Information gained will be included in an Environmental Impact Assessment, that is a key component of the consent application for these works.

Specialist ecological surveyors will be instructed to undertake this process, requiring simple non- intrusive pedestrian access to land to take photographs and note species and habitats. We would therefore be grateful if you could consent to these surveys by completing the attached form and returning it in the self-addressed envelope, or by contacting me on the numbers below or email at vattenfallinnorfolk@consentssolutions.com. If you do not occupy the land and would prefer the current occupier to be contacted, please could you let us know the details of the best person to contact.
