Dear Colleagues,

It's been an important month for the Norfolk Vanguard project. We have really enjoyed working with you and also undertaking a further 8 public drop in sessions - where the team presented plans for the Norfolk Vanguard Wind Farm.

Up to the current drop in, written feedback from under 24 year olds has only been 3% and under 18 - 1% . This is a great shame as young people have important views that we would like to capture to ensure the project reduces negative impacts whilst maximising benefits and opportunities.

Please could I ask you to bring the feedback form to the attention of your students? This is NOT the same survey monkey form that students filled out during the 3DW education programme. Also it is worth noting that it links to the REAL programme (see the attached summary consultation) and NOT the scenario that we had developed to ensure students appreciated the process and issues relating to wind farm development.

It would be especially valuable for those that joined us for the 3DW programme and/or the drop-in's, as it is a rare opportunity to have an accountable say on a Nationally Significant Infrastructure Project that is on the doorstep. The input you and your students make will go (anonymously) to Planning Inspectorate. Vattenfall will also take account of the views and suggestions made as the final plans are developed for submission to the inspectorate.
