I want to stay on for the open hearing but I won't know until the day whether it will be possible. I suspect the east of the country and those near landfall will be underrepresented and I would like some way of formally complaining about this so that the Inspectorate doesn't go away with the impression that we don't care or have a voice.

Hello

I have two questions regarding the Norfolk Vanguard preliminary meeting and open floor hearing on Monday 10th December.

As I explained previously (but did not hear back from the PI) we are based near the landfall site at Happisburgh – and it is a four hour round trip – much of it cross country - to get to King's Lynn which is causing us some logistical issues.

1. Preliminary Meeting – 10th December

We will be attending in the audience but we would like to make a couple of brief points regarding the future hearings – based on new information received - and I want to clarify that this meeting (as has been the case with a previous one we attended) would allow for a request to be made from the floor at some point. I wanted to make this clear now in case we were unable to be there before it starts. I can confirm it is a procedural question. I can put this in writing if you prefer but I would need to hear back promptly to allow time to do this.

2. Open Hearing – 10th December

Again given the distance and other commitments we may not be able to stay on to attend the open hearing in the evening. We do want to make the point that a) the location is completely impractical for people living on the east of the county and b) if we are unable to stay on, is there an option to make a short written statement to reflect what we would have said - and how should that be delivered and by when?

3. Provisional Open Hearing – 30th January

This might provide the opportunity to make that statement but I see it is provisional. Please can you confirm that the venue choice will be more democratic to take into account all of the communities affected and I refer you back to point 2.b above if there is a chance that this hearing will not take place.
