Further to our telephone conversation on Thursday 6<sup>th</sup> December in regard to the Specific Issue Hearings which have been highlighted in the Rule 6 letter the NFU/Land Interest Group(LIG) would be grateful if the Examining Authority would consider holding a specific hearing which covers Land Use issues as highlighted in Annex B. Further we would like the topics of agricultural field drainage and water supplies to be covered as highlighted in our submission, the type of link boxes and the siting of these.

Further we would like access routes to the scheme corridor to be covered.

We would also like confirmation that issues in regard to the use of HVDC cables and the Converter Station will be covered at a specific hearing. We would also like this to cover the crossing point of Hornsea 3 project and the Vanguard project.

We are very pleased to see that there will be hearings on the draft DCO and Compulsory Acquisition.

We confirm that we will not be attending the preliminary hearing or the open floor hearing on the 10<sup>th</sup> December 2018.
