Early notification of potential new interest – Plot 01/04

As part of the Applicant's ongoing diligent enquiry, it has become apparent through a conversation with a third party that the following entities could conceivably have an interest in Plot 01/04 near the landfall:

1. Decca Limited
2. Thales Information Systems Limited (now dissolved)
3. Successors in title to the interests of Decca Limited c/o Michael William Peter Seabrook - Both to the Company Secretary and Director
4. Successors in title to the interests of Decca Limited c/o Ewan Angus McCrorie.

The Applicant has previously erected unknown owner notices on or around Plot 01/04 and it is through this means that the conversation with a third party took place. The Applicant has not received any title information to suggest that these parties do have a current interest. Accordingly, any action being taken by the Applicant at this stage is precautionary only.

If the parties listed above can demonstrate a compensatable interest in the land, the Applicant will seek to negotiate to purchase these interests, and will continue to promote the Order with powers of compulsory acquisition included in respect of Plot 01/04.

The Applicant therefore considers that it is prudent to notify the Planning Inspectorate in case the Planning Inspectorate is minded to include the above parties in their database of land interests. The Applicant will maintain a watching brief on this issue and will update the Planning Inspectorate if there is any change to the position.
