In addition National Grid have requested that the promoter seek that the permanent rights for the overhead lines be extended for the full extent of the affected land ownership to ensure that all necessary rights are in place and available for the overhead lines as they sit within the affected land owners interests. This will ensure that existing rights are not affected by either the overhead line modification works or the use of powers for compulsory acquisition of rights within the Order.

We understand that the Applicant is submitting a revised draft DCO at Deadline 2 with amended wording at Article 4 to allow for this limit of deviation, together with updated Works Plans and Land Plans.
