Planning Act 2008, Vattenfall Wind Power Limited, Proposed Norfolk Vanguard Offshore Wind Farm Response to Examining Authority's Rule 8 Letter

On 26 June 2018, the Marine Management Organisation (the "MMO") received notice under section 56 of the Planning Act 2008 (the "PA 2008") that the Planning Inspectorate ("PINS") had accepted an application made by Norfolk Vanguard Limited (the "Applicant") for determination of a development consent order for the construction, maintenance and operation of the proposed Norfolk Vanguard Offshore Wind Farm (the "DCO Application") (MMO ref: DCO/2016/00002; PINS ref: EN010079).

The DCO Application seeks authorisation for the construction, operation and maintenance of Norfolk Vanguard offshore wind farm, comprising of up to 200 wind turbine generators together with associated onshore and offshore infrastructure and all associated development ("the "Project").

#### 1. MMO Comments on Relevant Representations (RRs)

### Maritime and Coastguard Agency (MCA)

1.1 The MMO notes that the MCA remains concerned regarding the indicative layout of the Norfolk Vanguard offshore wind farm turbines and their potential impact on search and rescue (SAR) capabilities. Provision for approval of the final design plan has been reserved in the draft DMLs at Schedules 9 to 12 and the MMO advises that consultation would take place with the MCA on the proposed final design plan to ensure SAR issues are fully accounted for where possible in the Norfolk Vanguard wind farm design plan. The MMO defers to the MCA's expert opinion on whether they are comfortable that an acceptable layout plan can be agreed post consent.

#### **Eastern Inshore Fisheries Conservation Authority (IFCA)**

1.2 The MMO supports the Eastern IFCA's assertion that the use of a local Fisheries Liaison Officer, the Kingfisher Information Service and Notice to Mariners applies to the operation and maintenance phases as well as the construction phase.
