Proposed Norfolk Vanguard accompanied site inspection itinerary – 25 and 26 March 2019

The itinerary for the accompanied site inspection can be found below.

Please note that the Panel's inspection of sites is not an opportunity to provide any oral representations on the project or discuss evidence. It is an opportunity for the Panel to look at the physical features that can be seen on, or from the sites. Participants may be invited by the Panel to point out specific features or sites of interest.

Joining the site inspection

The site inspection will commence at Happisburgh Community Car Park, Beech Road, Happisburgh, NR12 OPR on Monday 25 March 2019 at 10.00am. Parking will be free of charge for participants. Transport to accompany the Panel will be provided, however space on the minibus for members of the public wishing to attend will be on a first-come, first-served basis. Once the vehicle is at capacity, participants will be required to use their own vehicles to follow the itinerary. Participants are asked to assemble promptly at the car park - the Panel will not wait for parties who are not present at the start point at the notified time.

A second day of site inspections will take place on Tuesday 26 March 2019, starting at Necton Community Centre, 13 Tun's Road, Necton, PE37 8EH at 10.00am

Clothing

It will be necessary for all parties to wear appropriate sturdy footwear and weather-proof clothing. All parties are advised to bring and wear high visibility jackets, if they have them, when walking on the public highway.

Sites on private land

Access onto private land is at all times by permission of the person controlling it; householders, occupiers and landowners may refuse to allow some persons accompanying the Panel onto their land. Under those circumstances, the Panel will decide whether or not to proceed with that part of the inspection and may ask those refused access to wait outside.
