## 1 INTRODUCTION

---

### 1.1 Project Background

1. Norfolk Vanguard Limited ('the Applicant', an affiliate company of Vattenfall Wind Power Limited (VWPL)) is seeking a Development Consent Order (DCO) for Norfolk Vanguard, an offshore wind farm in the southern North Sea.

### 1.2 Purpose of the Statement of Commonality

2. This document (version 6) provides the Examining Authority with an overview of the final position of each Statement of Common Ground (SoCG) between the Applicant and the interested parties in relation to Norfolk Vanguard.
3. Throughout the Environmental Impact Assessment (EIA), an Evidence Plan Process (EPP) was undertaken which provided a framework for consultation with the relevant stakeholders. Each SoCG reflects discussions throughout the EPP and pre-submission consultation where appropriate, as well as ongoing post submission consultation, where applicable.
