REQUEST FOR INFORMATION FOLLOWING THE HIGH COURT'S DECISION TO QUASH THE NORFOLK VANGUARD OFFSHORE WIND FARM ORDER 2020

Thank you for your letter dated 29 April 2021 regarding the above.

Please be advised that the proposed onshore substations located at Necton, Norfolk for both Norfolk Vanguard and Norfolk Boreas were not considered by Natural England to have any implications for statutory nature conservation designations. Therefore, it is unlikely that we will be providing further representations on these matters.

However, we do have other concerns which we would like to see addressed during the redetermination of the Norfolk Vanguard project, or should the Examination be re-opened. We wish to highlight the need to revisit the previous assessment of the proposal in the light of a) the subsequent Hornsea Project Three determination (and associated Habitat Regulation Assessment), including with regard to the provision of compensatory measures for impacts on European sites; and b) with respect to the further information requirements set out in the recent Norfolk Boreas Secretary of State consultation.
