1. INTRODUCTION

- 1.1 This document provides a guide to Norfolk Vanguard Limited's (the **Applicant**) Development Consent Order (**DCO**) application for the Norfolk Vanguard Offshore Wind Farm (the **Project**). It sets out which document version is the most up to date.
- 1.2 This is a live document and will be updated when updates or revisions to existing documents are made and new documents are submitted to the Planning Inspectorate.
- 1.3 This document was originally requested by the Planning Inspectorate through the Rule 8 letter dated 19 December 2018.

2. MASTER DOCUMENT LIST

- 2.1 The master document list table is set out on the following pages and provides a full list of all the documents submitted to date, indicating either the latest revision (if applicable) or when a new document was submitted.
