CORRECTION OF ERRORS IN DEVELOPMENT CONSENT DECISIONS

DATE 6 September 2022

The Secretary of State received a request dated 23 March 2022 from Norfolk Vanguard Limited (“the Applicant”) for the correction of errors in the Norfolk Vanguard Offshore Wind Farm Order 2022 (“the Order”), under section 119 of, and Schedule 4 to, the Planning Act 2008.

The Secretary of State has made the following corrections to the Order:

Corrections to Schedule 1

Schedule 1 (Authorised Project), Part 3 (Requirements), requirement 16(17)(t)

At “(t)” omit “In circumstances where development commences under the Hornsea Three Offshore Wind Farm Development Consent Order is made, there shall be trenchless crossing of the”

Secretary of State’s rationale:

To correct a drafting error.

Schedule 1 (Authorised Project), Part 3 (Requirements), requirement 23(2)(a)

After “research questions;” omit “and”

Secretary of State’s rationale:

To correct a drafting error.

Corrections to Schedule 6

Schedule 6 – land in which only new rights etc., may be acquired; minor crossings inc. highway

In column 1, after “18/02” omit “19/05”

Secretary of State’s rationale:

To correct a drafting error.

Corrections which the Secretary of State has not made

Article 2, Interpretation –

For “outline Norfolk Vanguard Haisborough, Hammond and Winterton Special Area of Conservation site integrity plan” means the document certified as the outline Norfolk Vanguard Haisborough, Hammond and Winterton Special Area of Conservation site integrity plan by the Secretary of State for the purposes of this Order under article 37;” substitute

“outline Norfolk Vanguard Haisborough, Hammond and Winterton Special Area of Conservation cable specification, installation and monitoring plan” means the document certified as the outline Norfolk Vanguard Haisborough Hammond and Winterton Special Area of Conservation cable specification, installation and monitoring plan by the Secretary of State for the purposes of this Order under article 37;”

This correction has not been made as a consequence of our decision to retain the specific provision in paragraph 29(h) of Schedule 17 to the Vanguard Development Consent Order requiring the applicant to still comply with the mitigations contained in the site integrity plan.

Article 37 (1)(y) (Certification of plans etc)

At “y” after “outline Norfolk Vanguard Haisborough, Hammond and Winterton Special Area of Conservation” omit “site integrity plan” and substitute “cable specification, installation and monitoring plan”

This correction has not been made as a consequence of our decision to retain the specific provision in paragraph 29(h) of Schedule 17 to the Vanguard Development Consent Order requiring the applicant to still comply with the mitigations contained in the site integrity plan.

Schedule 17, Part 3, paragraph 29(h)

Replace reference to "outline Norfolk Vanguard Haisborough, Hammond and Winterton Special Area of Conservation site integrity plan" with "outline Norfolk Vanguard Haisborough, Hammond and Winterton Special Area of Conservation cable specification, installation and monitoring plan"

This correction has not been made as paragraph 29(h) of Schedule 17 is intended to require the applicant to still comply with the mitigations contained in the site integrity plan despite the compensation requirements.
