Dear Sirs

We are instructed by Cadent Gas Limited (Cadent).

Cadent has been liaising with the Applicant in relation to the impacts of the proposed scheme on its existing apparatus and interests and to agree protective provisions to be included within the DCO to ensure that its apparatus and land interests are adequately protected and to include compliance with relevant safety standards. The form of the protection provisions is not yet agreed and, in the interests of costs and expediency while the parties continue to negotiate, Cadent does not submit any further detailed written representations at this time.

Cadent reserves the right to make further representations as part of the examination process and, if negotiations do not progress, will submit to the Examining Authority its preferred protective provisions by the deadline for the submission of comments on the revised draft DCO (Deadline 3).

Cadent has not received a draft SoCG from the Applicant but is otherwise willing to enter into such a statement to record the level of agreement reached as part of future deadlines.
