Dear Mr Johansson

I am sending you this SNH response on behalf of my colleague Erica Knott.

Thank you for your recent correspondence regarding the Hornsea Project Three wind farm. This was sent to our previous Chief Executive Ian Jardine, please note our new Chief Executive is Francesca Osowska. Our marine energy team are aware of the various offshore wind projects in English waters through dialogue with our equivalent contacts in Natural England. For this project, we have now reviewed the written questions issued by the Examining Authority. We do not see any aspect of these questions that requires our input directly into this process as an Other Party.

You may however, be interested to know that we have been discussing with Marine Scotland a clearer process which enables proper account to be taken of cumulative effects from all offshore wind farm projects (build, consented or proposed) in UK waters. These discussions are ongoing and we would encourage alongside our discussions with both Marine Scotland also our equivalent SNCBs that the UK regulators may wish to consider how best to take account of cumulative effects both at the individual project level but also at the strategic planning level when identifying new sites. These cumulative effects are most likely to encompass effects on seabirds from operation of wind farms and the cumulative underwater noise effects during construction on marine mammals.

I trust this is of assistance and am happy to follow up on any further queries you may have on this matter.
