We write further to the above and the Examining Authority's Further Written Questions and Requests for Information issued on 19 December 2018.

In answer to Question 2.14.4:

The Crown Estate Commissioners ("the Commissioners") are making good progress with the Applicant to agree a position which would provide the Commissioners with sufficient assurance as to the way in which compulsory acquisition powers of third party interests in Crown land forming part of the Crown Estate may be exercised. This will permit the Commissioners to provide their consent to the compulsory acquisition of the third party interests in the relevant plots for the purpose of section 135(1) of the Planning Act 2008 and their consent to the provisions of the draft development consent order for the purpose of section 135(2) of the Act (together "the consents").

It is anticipated that such position will be agreed to permit the Commissioners to provide the consents prior to Deadline 6.
