We are instructed by Cadent Gas Limited ("Cadent").

This statement should be read in conjunction with the written submissions submitted on behalf of Cadent on 15 January 2019.

The parties have agreed the protective provisions and other mechanisms that are required to safeguard Cadent's existing apparatus and mechanisms for the implementation of the Order in so far as it may affect Cadent's assets. The parties are now in the process of dealing with the drafting of the necessary documents and it is anticipated that the proposed agreements will be entered into in the coming days. Once such documents are executed, Cadent will withdraw its submissions to the Application without the need for further changes to the dDCO.

In light of the above, Cadent does not intend to attend the Issue Specific Hearing to be held on 30

January 2019 in the interests of costs and expediency. We would be grateful if you could please withdraw Cadent's name from the list of attendees accordingly.
