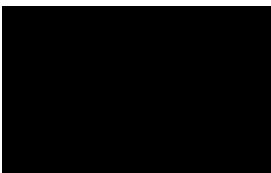
Submissions for Deadline 9 (Tuesday 26th March) will include the following items:
