**Paragraph 10 of Part 2 of Schedule 14: Plan for Work of the Steering Group**

Orsted Hornsea Project Three (UK) Limited (**Hornsea Three**) is writing to you in relation to the enclosed plan for the work of the Steering Group for the benthic compensation measures required by Schedule 14 of the Order (**Plan of Work**).

Paragraph 10 of Part 2 of Schedule 14 requires the Plan of Work to be submitted to and approved by the Secretary of State prior to commencement of the authorised development.

The Plan of Work must include the details listed in sub-paragraphs (a) to (d) of paragraph 10 relating to terms of reference, membership, scheduling of meetings and timetabling for preparation of Sandbank Implementation Plans and related reporting and review periods, plus the dispute mechanism.

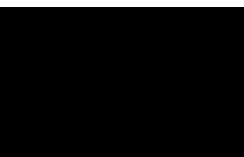
