## Orsted Hornsea Project Three

Dear Mr. Leigh: 01 December 2021

Orsted Hornsea Project Three (UK) Limited (**Orsted**) is writing to you for approval of the enclosed Sandbank Implementation Plan(s) (SBIPs¹) for The Wash and North Norfolk Coast Special Area of Conservation (WNNC SAC) and North Norfolk Sandbanks and Saturn Reef (NNSSR) SAC, in accordance with Schedule 14 Part 2 of the Hornsea Three Offshore Wind Farm Order 2020 (**the Order**).

Paragraph 12 of Part 2 of Schedule 14 requires the SBIPs to be submitted to the Secretary of State for approval and provides that no cable installation works in Work No. 2(c) and (d), Work No. 3(c) and (d) and Work No.5 may be commenced until the SBIPs have been approved in writing by the Secretary of State. The SBIPs must include the details listed in sub-paragraphs (a) to (f) of paragraph 13 and must accord with the principles outlined in the Sandbanks Compensation Strategy<sup>2</sup>. The enclosed submission contains the information required by sub-paragraphs (a) to (f) and has been prepared in accordance with the Sandbanks Compensation Strategy.
