I write on behalf of the Applicant, Eggborough Power Limited, in respect of Deadline 9 of the Examination into the Eggborough CCGT Project.

Please find enclosed the following documents, which together comprise the Applicant's Deadline 8 submission:

- Document Ref. 1.2 – Application Guide (Rev. 9.0).
- Document Ref. 2.1 – Draft DCO (Rev. 7.0) - This is the Applicant's final version of the draft DCO in the SI template. It has been validated accordingly. A Word version is also attached. The draft DCO has been updated following minor formatting amendments which have been made so as to comply with the SI template requirements, as well as to update the definition of "Application Guide" to include the final revision number and date of the Guide. Schedule 12 Part 2 has also been updated to reflect changes brought about by the Digital Economy Act 2017, which updated the provisions of the Communications Act 2003 and gave rise to a new electronic communications code. This part of Schedule 12 has been updated accordingly to incorporate these changes. There are no other amendments to the draft DCO.
- Document Ref. 2.14 – Draft DCO - Comparison to Deadline 8 Version – This shows the changes made to the draft DCO since Deadline 8 (as set out above).
- Document Ref. 7.1 (Rev. 5.0) - Final signed Statement of Common Ground (SoCG) with North Yorkshire County Council (NYCC) and Selby District Council (SDC).

- Document Ref. 7.9 (Rev. 3.0) - Final signed SoCG with National Grid.
- Document Ref. 9.8 - Final agreed Section 106 with SDC and the Yorkshire Wildlife Trust on biodiversity enhancement. A signed version will be submitted before the end of the Examination.
- Document Ref. 9.9 (Rev. 2.0) - Compulsory Acquisition Update. The Applicant has reviewed the Book of Reference and will not be submitting a further version.
- Document 9.13 - Final agreed Section 106 with SDC on the demolition of the coal-fired station. A signed version will be submitted before the end of the Examination.
- Document 9.16 - Final agreed Planning Performance Agreement with NYCC relating to the discharge of requirements. A signed version will be submitted before the end of the Examination.

The Applicant awaits final comments from the Canal & River Trust on the SoCG between the parties and hopes to be able to submit a signed version before the end of the Examination.

The Application Guide (Document Ref. 1.2) has been updated for Deadline 9. Table 2.1 details the submission version of the document (the version submitted as part of the Application on 30 May 2017), where relevant, in addition to the current version of the document along with the date that the current version was submitted. The documents that have been updated and the new documents submitted for Deadline 9 are highlighted in yellow for ease of reference.
