I write on behalf of Sembcorp Utilities (UK) Limited (the 'Applicant') in respect of Deadline 5 of the examination (the 'Examination') into the Tees Combined Cycle Power Plant Project (the 'Project').

Scope of submission

For Deadline 5, the Examiner ('ExA') requested, amongst other things, responses to the ExA's Second Written Questions (if required) and responses to any additional information requested by the ExA.

However, we have been advised that the EA is currently experiencing staffing shortages due to the holiday season. As a result, the EA has advised that it is unable to provide comments on and/or agree to matters in the latest iteration of the SoCG prepared by the Applicant until 17 August 2018. This date is closer to Deadline 6 on 22 August 2018 and it







is therefore our intention to submit an updated SoCG at Deadline 6. This has been agreed with the ExA;

- Section 106 the Applicant has drafted the document and will shortly issue to Redcar and Cleveland Borough Council for review; and
- Leases with National Grid the Applicant has received the document back from National Grid's legal department and is in the process of working through the comments.

I trust that this letter and enclosures provide the information required from the Applicant for Deadline 5.
