

Application for Development Consent for Thanet Offshore Wind Farm Extension Case Ref: EN010084

Examining Authority's Note of Unaccompanied Inspection of Sites

Inspection 2a and 2b: Landfall Location and North Thanet Coast 10 and 13 December 2018

Background

The Examining Authority (ExA) undertook its second unaccompanied site inspections to support its examination of an application for development consent for the proposed Thanet Offshore Wind Farm Extension (the application) on 10 and 13 December 2018, around the dates of the Preliminary Meeting and Issue Specific Hearings 1 and 2 (ISH1 and ISH2).

Inspections were undertaken from publicly accessible land including highways and public rights of way. No access was required to private land, so advance permission to enter land was not required and these inspections could be undertaken on an unaccompanied basis.

The inspections were undertaken to view the proposed application site onshore and views to the existing Thanet Offshore Wind Farm and to the proposed Thanet Offshore Wind Farm Extension. Locations prospectively within the setting of the onshore development proposals in the application were also inspected.

The second unaccompanied inspections are recorded in this note, the purposes of which were:

- to inform the applicant, interested parties and other persons of actions already taken by the ExA; and
- to enable the applicant, interested parties and other persons to consider which additional sites the ExA might need to inspect.

The inspection of Pegwell Bay Country Park on 10 December 2018 extended further than the site inspection carried out on 30 October (US1) with better visibility and included a walk around Stonelees Nature Reserve and the northern edge of the Bay Point Sports Club site. The inspection on 13 December 2018 along the north coast of Thanet East from Margate continued the inspection of 30 October 2018 (US11).

Further site inspections may be required. The site inspection programme was discussed at the Preliminary Meeting held on 11 December 2018. The applicant, interested parties and other persons were provided with an opportunity to provide comments to the ExA on the approach that it should take to site inspections and to nominate site inspection locations. An opportunity has been provided to propose inspections of private land on an accompanied basis, should this be necessary.

Before agreeing to a site inspection at a particular location, the ExA will consider the degree to which it is necessary to visit a site that has been nominated for an inspection to inform it about the application. It may decide not to visit nominated locations where it considers that it is not necessary to see the features to be observed there. It may decide not to hold an accompanied site inspection if all relevant features can be observed and understood from locations in the public domain.

Arrangements for any accompanied site inspections have been included in the ExA's examination timetable and procedural decision to be issued after the preliminary meeting. If further inspections are carried out, further inspection notes will be published.

Particulars of the Inspections

The second unaccompanied inspection was undertaken in two parts by the ExA. The first part, USI2a was undertaken by Examining Inspectors Rynd Smith (Panel Lead), Jessica Powis and Stephen Bradley, with two Planning Inspectorate staff in attendance: Kate Mignano, Case Manager and Bart Bartkowiak, Case Officer. The purpose of the visit was for the ExA to become familiar with:

- the proposed onshore works including:
 - o the proposed cable landfall;
 - o Pegwell Bay Country Park; and
 - Stonelees Nature Reserve and its surroundings; and
 - the proposed sub station and grid connection locations at Richborough.

The second part, USI2b was undertaken by Examining Inspectors Rynd Smith (Panel Lead) and Stephen Bradley. The purpose of the visit was for the ExA to become familiar with:

• views to the existing Thanet Offshore Wind Farm and to the proposed Thanet Offshore Wind Farm Extension (the application site and surrounds offshore) from Margate and the north coast of Thanet.

The first part of the inspection (a) was undertaken by car and on foot on 10 December 2018 commencing at 14-10. Weather conditions were clear and dry with full cloud cover; adequate to appreciate short, medium and long range views towards the proposed development from each of the locations that were inspected. The inspection concluded at 16-00, with a drive past the proposed substation site.

The second part of the inspection (b) was undertaken by car and on foot on 13 December 2018 commencing at 14-45 in Central Margate, adjacent to the Turner Contemporary art gallery. Weather conditions were clear and dry with scattered clouds; wind E/NE; sea state slight to moderate; adequate to appreciate short, medium and long range views towards the proposed development from each of the locations that were inspected. The inspection concluded at 16-00 with a walk to the clifftop at Foreness Point. Individual locations inspected and the purposes of those inspections are recorded in the attached Annex.
