As you are aware, we act for London Array Limited who represent the consortium in the London Array wind farm project (being Orsted London Array II Limited, E.on Climate & Renewables UK London Array Limited, Masdar Energy UK Limited and Boreas (Investment) Limited) (together referred to in this letter as the Participants). The Participants have the benefit of interests in land affected by the proposed solar farm and which are proposed to be subject to compulsory purchase pursuant to the development consent order (DCO). The Participants have submitted relevant representations (RR-808) to Cleve Hill Solar Park and are an interested party for the purpose of the DCO proceedings.
