We act for National Grid Electricity Transmission.

We had reserved the right to appear at the CA hearing and also potentially the ISH Hearing on the drafting of the DCO.

We appear to be making good progress with the promoter in agreeing the protective provisions and therefore whilst not all matters are yet concluded, we do not see that it is necessary for us to attend these hearings at this stage in the Examination process.

We will continue to liaise with the promoter in connection with the final issues between the parties and will provide the ExA with a further update in due course. We anticipate that we can resolve matters without appearing at any further hearings but we will be able to confirm this in the near future.
