Participation, conduct and management of Hearing

This is the third Open Floor Hearing in this Examination. It is being held to allow Interested Parties who have not been able to attend previous Hearings to make oral representations about the application, or for Interested Parties to speak on any new matters that they have not been able to raise so far. The Examining Authority has noted contributions provided at Open Floor Hearing 1 and Open Floor Hearing 2 and repetition of those matters will not assist the Examination of the application.

The Hearing will be subject to the powers of control of the Examining Authority and registered participants will be invited to make an oral representation to us. Each Interested Party will be strictly limited to 5 minutes. Please run through your representation in advance to ensure it can be completed within 5 minutes to avoid us having to cut your contribution short. To facilitate an efficient hearing, we would also ask those with common points to come together and to nominate a spokesperson or representative speakers to cover specific topics, so as to avoid repetition.

All representations should be based on the Relevant Representations or Written Representations made by the person by whom (or on whose behalf) the oral representations are made¹. However, representations made at the Hearing should not simply repeat matters previously covered in a written submission. Rather, they should draw attention to those submissions in summary form and provide further detail, explanation and evidential corroboration to help inform the Examining Authority.

The Examining Authority may ask questions about representations or ask the Applicant or other party to comment or respond.

Breaks will be taken during the hearing as directed by the Examining Authority.
