1 INTRODUCTION

1. This document provides a guide to Cleve Hill Solar Park Limited's (the Applicant's) Development Consent Order (DCO) application for Cleve Hill Solar Park (the Development). The DCO application is for the construction, operation and maintenance and decommissioning of Cleve Hill Solar Park, a solar photovoltaic (PV) array electricity generating facility and electrical storage facility, with a total capacity exceeding 50 MW.
2. Provided within this document is a full list of the documents that have been submitted by the Applicant as part of the application and examination to the Planning Inspectorate. It is a live document and will be updated when revisions are made.
3. For ease of navigation, the documents have been grouped according to the information they relate to, and the relevant stage of the examination.
