1. We act for Cleve Hill Solar Park Limited (“**Cleve Hill**”) in relation to the matters raised in TLT’s letter to you dated 12 November 2019. Pinsent Masons LLP continues to act for Cleve Hill in respect of the DCO application bearing reference EN010085.
2. We have adopted the defined terms used in that letter.
3. We do not accept that there has been any breach of confidentiality by reference to the terms of the SPA in the Response. This SPA was referred to in open court on 6 December 2018. As a consequence, the SPA has clearly lost the necessary quality of confidentiality which would make any further disclosure a breach of confidence.
4. TLT wrote to Cleve Hill and to this firm on 30 October 2019 making this same allegation of breach of confidence, to which we responded as above. We are yet to receive any response from TLT in reply to our letter.
5. On the above basis we do not believe that it is necessary for you to take any steps in relation to the content of the Response, or to take any steps in future in relation to any submissions also referring to the SPA.
