# NORFOLK VANGUARD OFFSHORE WIND FARM



Dear

I am writing to keep you informed about the progress of the Norfolk Vanguard Offshore Wind Farm project and to invite you to our next series of drop-in exhibitions taking place in March/early April.

Following the first drop-in exhibitions introducing our very early proposals last October, attended by some 800 people, we are holding a second, expanded round of drop-in events. These will show and ask for views on our latest thinking on the project, including our response to feedback received to date.

We will provide information on the options we are considering to locate landfall (of cables from the wind farm) and cable relay station, the underground cable corridor and zone of investigation for locating the substation to connect into the National Grid at the existing 400kV National Grid substation near Necton. In response to requests for more visual aids to illustrate the onshore works, a digital model will show our current thinking. We will also respond to questions raised and local interest in noise, construction impacts, opportunities and benefits.

We shall also be introducing the Norfolk Boreas project and highlighting how we intend it to share onshore infrastructure with Norfolk Vanguard in order to minimise impacts during construction and operation.

Here with we attach an advance copy of our latest newsletter, setting out the dates and venues of the next public information events. Like our first newsletter, this edition will be delivered to the 35,000 households within our original search area, from 7th March onwards.
