Action Points from Issue Specific Hearing 3 and 4

Action Points from Issue Specific Hearing 3 (**ISH 3**) on onshore effects including the draft Development Consent Order and from Issue Specific Hearing 4 (**ISH 4**) on offshore effects including the draft Development Consent Order were published on 22 and 24 January 2020 respectively.

The Applicant has produced an Action Point tracker to signpost where each Action Point from ISH 3 and ISH 4 is addressed. This document has been provided with the Deadline 4 submissions (document reference ExA.AS-10.D4.V1) and the Applicant will update this again at Deadline 5.

In accordance with Action Point 2 and Action Point 3 from ISH 3, the Applicant has arranged a meeting with Broadland District Council, Cawston Parish Council and Norfolk County Council for the 12 February

2020 to discuss the revised Cawston Highway Intervention Scheme and alternative access routes. The agenda has been agreed by all parties and the Applicant has submitted this at Deadline 4 (ExA.AS-6.D4.v1). The Applicant has also submitted a Technical Note (ExA.AS-2.D4.V1) on the revised scheme for all parties to review in advance of the meeting. The assessment of potential alternative access routes is ongoing; information on this will be available to discuss at the meeting, however the Applicant will not be in a position to submit detailed documents on these alternatives to parties in advance of the meeting on 12 February 2020. The Applicant proposes to explain these documents at the meeting and then allow stakeholders appropriate opportunity to review and comment on the documents following the meeting and in advance of Deadline 5.

Accompanied Site Inspection

The Applicant has also submitted the information requested by the ExA during the Accompanied Site Inspection on 23 January 2020; Figure from the Norfolk Vanguard Consultation Report and explanations of differences (ExA.AS-9-D4.V1) and the Cawston Parking Survey (ExA.AS-2.D4.V1, Appendix B).

Late Submissions

The Applicant notes that a small number of submissions have been published recently by the Planning Inspectorate - in particular, The Royal Society for the Protection of Birds' submission published on 21 January 2019. The Applicant therefore proposes to respond to this and, where relevant, other post-Deadline 3 submissions at Deadline 5.
