1 Introduction and Purpose

- 1.1 This document outlines how Norfolk Boreas Limited (the **Applicant**) has addressed each of the relevant Actions Points published by the Examining Authority (ExA) following Issue Specific Hearings 3 and 4.
- 1.2 The Action Points from the Issue Specific Hearing (**ISH**) on Onshore effects including the draft Development Consent Order (**DCO**), (ISH 3) held on 21 January 2020 were published by the Planning Inspectorate on 22 January 2020¹; the Action Points from ISH 4 on Offshore effects including the draft DCO held on 22 January 2020 were published by the Planning Inspectorate on 24 January 2020².
- 1.3 The intention of Table 1 and Table 2 below is to assist the ExA and Interested Parties in locating the documents submitted at Deadlines 4 and 5- which respond to the Action Points.
