1 INTRODUCTION

1.1 Project Background

1. Norfolk Boreas Limited ('the Applicant', an affiliate company of Vattenfall Wind Power Limited (VWPL)) is seeking a Development Consent Order (DCO) for Norfolk Boreas, an offshore wind farm in the southern North Sea.

1.2 Purpose of the Statement of Commonality

2. This document provides the Examining Authority with an overview of the position of each Statement of Common Ground (SoCG) between the Applicant and the interested parties in relation to Norfolk Boreas at Deadline 2.
