NORFOLK BOREAS – Revised timetable

In light of the current coronavirus emergency and changes to the Norfolk Boreas examination timetable, Oulton Parish Council (OPC) respectfully requests a reconsideration of the revised timetable.

It would appear that the Examining Authority is still intending to complete the Examination on 12th May 2020, without the need to hold any further Issue Specific Hearings, Open Floor Hearings or Accompanied Site Inspections. OPC is extremely concerned at the prospect of what would be lost from the fairness, transparency and detail of the examination process, if that were to be the case.

In addition, OPC suggests that it is unsafe to assume that those taking part in the examination process will be able to continue to participate fully by written submissions, and that Local Authorities, agencies and other Interested Parties will be able to respond as they would have done before the current emergency. In the coming weeks it is likely that many people will fall ill, or be fully occupied with caring for those who do, and will not be able to continue with the written aspect of the examination process.

This situation is unprecedented, but the Planning Act 2008 does allow for an Examination to be put on hold in certain circumstances (see extract below).

Therefore, in the interests of fairness and due process, Oulton Parish Council would be grateful if the ExA could re-consider the revised timetable, and allow for the examination to be resumed in full at a later date.
