1 Introduction

1. Throughout the development of Norfolk Boreas ('the Project'), the Applicant has undertaken extensive consultation with a range of stakeholders with the aim of open collaboration to maximise the benefits of the Project.
2. Norfolk Boreas is being developed alongside the Norfolk Vanguard project. If both projects are constructed, they would, because of their location, have similar impacts as a result of their strategic development and shared cable corridor. Accordingly, the Applicant, jointly with Norfolk Vanguard, has undertaken consultation with Natural England and the MMO in relation to potential in-principle compensation measures to support a Habitats Regulations derogation case.
3. This consultation was undertaken primarily in response to a request for information for the Norfolk Vanguard project from the Department for Business, Energy and Industrial Strategy (BEIS) dated 6 December 2019. However, that consultation is directly relevant to and has informed the Applicant's response to the Examining Authority's further written questions, which have requested information on derogation including possible compensation measures. Consultation with other relevant stakeholders e.g. Eastern Inshore Fisheries and Conservation Authority (EIFCA), The National Trust and the Royal Society for the Protection of Birds (RSPB) also took place as part of the Norfolk Vanguard led consultation and has informed the Norfolk Boreas response in a similar way.
4. The principle of consultation has been to engage actively and openly, sharing information on a without prejudice basis, to provide parties with the opportunity to consider and contribute towards the development of in-principle compensation measures as part of a derogation case. Written feedback received from the parties has been taken into account in the in-principle compensation measures proposed.
5. Consultation was undertaken with offshore stakeholders, in particular Natural England and the Marine Management Organisation (MMO) regarding matters relating to Habitats Regulations Assessment (HRA) and possible compensation, covering the following topics, as explained further in Section 2 of this document:
 - Ornithology
 - Kittiwake of Flamborough and Filey Coast Special Protection Area (SPA), possible mitigation and compensation;
 - Lesser black backed gull (LBBG) of Alde-Ore Estuary SPA, possible mitigation and compensation
 - Haisborough, Hammond and Winterton Special Area of Conservation (SAC)
 - Site Integrity Plan
 - Mitigation; and
 - Possible compensation

2 Consultation with Stakeholders

6. The consultation with Natural England and the MMO included a series of conference calls, a face to face meeting and a large number of submissions regarding additional mitigation proposals and in-principle compensatory measures.
7. Due to the timescales for the two projects Norfolk Vanguard Limited lead on the derogation consultation with the Norfolk Boreas team in attendance at the majority of meetings and calls. Although Norfolk Vanguard led the consultation, all entries listed in Table 1 are directly relevant to Norfolk Boreas and have been considered when developing this in principle derogation case.
8. In addition to the stakeholder consultation outlined below, the Applicant engaged with the supply chain, including turbine manufacturers, construction vessels, decommissioning specialists and cable protection manufacturers in order to refine the design envelope and propose new mitigation commitments based on the latest industry developments.
