1. INTRODUCTION

1.1 This document provides a guide to Norfolk Boreas Limited's (the **Applicant**) Development Consent Order (**DCO**) application for the Norfolk Boreas Offshore Wind Farm (the **Project**). It sets out which document version is the most up to date.

1.2 This is a live document and will be updated when updates or revisions to existing documents are made and new documents are submitted to the Planning Inspectorate.

2. MASTER DOCUMENT LIST

2.1 The master document list table is set out on the following pages and provides a full list of all the documents submitted to date, indicating either the latest revision (if applicable) or when a new document was submitted.
